

# NOTICE OF FINAL PUBLIC MEETING

## to be held by RE Ingersoll 1 ULC Regarding a Proposal to Engage in a Renewable Energy Project

**Project Name:** RE Ingersoll 1

**Project Applicant:** RE Ingersoll 1 ULC

**Project Location:** The project is located on 41st Line, northeast of Ingersoll.

**Dated at the Townships of Zorra and South West Oxford on this the 16th of June, 2011**

RE Ingersoll 1 ULC is planning to engage in a renewable energy project in respect of which the issuance of a renewable energy approval is required. The proposal to engage in the project and the project itself is subject to the provisions of the Environmental Protection Act (Act) Part V.0.1 and Ontario Regulation 359/09 (Regulation). This notice must be distributed in accordance with section 15 of the Regulation prior to an application being submitted and assessed for completeness by the Ministry of Environment.

This Final Public Meeting is being held to provide information on the proposed project. The Public Meeting will be an open house format.

### **Project Description:**

Pursuant to the Act and Regulation, the facility, in respect of which this project is to be engaged in, is a Class 3 Solar Facility. If approved, this facility would have a total maximum name plate capacity of 9.5 MW. The project location is described in the map below.

The Draft Project Description Report titled *Project Description Report RE Ingersoll 1 Solar Project* describes the project as a solar electric generating facility that will utilize photovoltaic (PV) panels installed on fixed racking structures. DC electricity generated from the PV panels is converted to AC electricity by an inverter. The voltage level of the AC electricity produced by the inverters is stepped-up to distribution level voltages by a series of transformers. A written copy of the Draft Project Description Report was made available for public inspection on April 23, 2010 at [www.ontariosolarfuture.ca](http://www.ontariosolarfuture.ca), and at the local municipal office. Further, the applicant has prepared supporting documents as per Ontario Regulation 359/09.
