

NOTICE OF A PROPOSAL

by RE Midhurst 3 ULC and RE Midhurst 4 ULC to Engage in a Renewable Energy Project and Notice of Posting to Environmental Registry

Project Name: RE Midhurst 3 Solar Project

Project Location: The Project is located on Line 5 North in Oro-Medonte, northeast of Barrie.

Project Name: RE Midhurst 4 Solar Project

Project Location: The Project is located north of Highway 11, east of Line 5 North and west of Line 6 North in Oro-Medonte, northeast of Barrie.

Dated at the Township of Oro-Medonte this the 3rd of December, 2011

RE Midhurst 3 ULC and RE Midhurst 4 ULC are each planning to engage in a renewable energy project in respect of which the issuance of a renewable energy approvals are required. The proposals to engage in the projects and the projects themselves are subject to the provisions of the *Environmental Protection Act (ACT)* Part V.0.1 and Ontario Regulation 359/09 (Regulation). This notice must be distributed in accordance with section 15.1 of the Regulation following the posting of the projects on the environmental registry.

Project Description:

Pursuant to the Act and Regulation, the facilities, in respect of which these projects are to be engaged in, are Class 3 Solar Facilities. If approved, these facilities would have a total maximum name plate capacity of 10 MW (RE Midhurst 3) and 6.5 MW (RE Midhurst 4). The project locations are shown in the map below.

Proposals for renewable energy approvals in respect of the renewable energy projects have been posted on the environmental registry (www.ebr.gov.on.ca, Registry Number: 011-5211) for Midhurst 3 and (www.ebr.gov.on.ca, Registry Number: 011-5212) for Midhurst 4.
